NOTIFICATION

Sub: Appointment of Six (06) Posts (Bengaluru – 05 and Belagavi Bench – 01) of State Information Commissioners in the Karnataka Information Commission.

The Government of Karnataka has constituted a body known as the Karnataka Information Commission to perform the functions assigned to it under the Right to Information Act, 2005. The present composition of the Karnataka Information Commission can be seen at www.kic.gov.in. The powers and functions of the State Chief Information Commissioner and the State Information Commissioners in the Karnataka Information Commission are as per Chapter V of the Right to Information Act, 2005.

Chapter-IV of the Right to Information Act 2005, provides that the State Information Commissioner shall be a person of eminence in public life with wide knowledge and experience in law, science and technology, social service, management, journalism, mass-media or administration and governance.

It is proposed to fill up Six (06) vacant posts of State Information Commissioners in the Karnataka Information Commission.

1. Bengaluru – 05
2. Belagavi - 01


In this view earlier, Government Notification No: DPAR(AR) 25 RTI 2022 dated: 18.07.2022 issued for the post of State information Commissioner of Belagavi Bench is hereby withdrawn with immediate effect.

The Information Commissioner shall not be a Member of Parliament or Member of the Legislature of any State or Union Territory, as the case may be, or hold any other office of profit or connected with any political party or carrying on any business or pursuing any profession.

The terms of office and conditions of service of the State Information Commissioner shall be as provided under section 16 of the Right to Information Act, 2005 read along with the Right to Information (Terms of office, Salaries, Allowances and other Terms and Conditions of Service of Chief Information Commissioner and Information Commissioners in the Central Information Commission, State Chief Information Commissioner and State Information Commissioners in the State Information Commission) Rules, 2019, and any notifications, rules and amendments issued under the said Act from time to time. **Applicants should be willing to serve any Bench in Karnataka.** Selected Candidates should be ready to take oath on the date fixed by Hon'ble Governor.
